## **Preconditions of being admitted to the comprehensive examination**

### **Minimum requirements**

MSc or MA or equivalent university studies with successful final examination or defence of degree thesis, as proven by a degree certificate

Earning at least 120 credits and all “programme credits” prescribed in the curriculum of the doctoral school (80 credits until the end of the 3rd semester)

Publications: Minimum 2 articles published (or accepted for publication), at least 1 of these articles must be published in a peer-reviewed journal referenced in the “Web of Science” or Scopus database. The minimum „sum of the points” must be 8.

### **Required documents (2 copies)**

Application form (*available at the administration (BME K.261.)*)

Professional CV

Synopsis of the planned dissertation

List and copies of scientific publications

Copies of the degrees, certificates (*The original ones must be presented at the administration when handing in the documents*)

## **Comprehensive examination**

The supervisor shall deliver the supervisory assessment of the student’s performance to the chair of the committee in electronic form at least one week before the set date of the exam. At least one week before the exam, the examinee submit the brief summary of results achieved to date to the committee together with the papers published or sent for publication.

## **In-house defence**

Defence conducted in a professionally competent educational organizational unit

## **Submission of Doctoral Thesis**

The doctoral candidate shall submit the doctoral thesis within three years starting from the comprehensive examination.

### **Minimum requirements**

Absolutorium

Proficiency in two foreign languages is required

Publications:

- Minimum 2 articles published (or accepted for publication) in foreign language (not Hungarian) and at least 1 of these articles must be published (or accepted for publication) in a peer-reviewed journal referenced in the “Web of Science” or “Scopus” database

- Minimum 4 articles published (or accepted for publication), which relate to the thesis points.
  - at least 1 of these articles must be published (or accepted for publication) in a peer-reviewed journal referenced in the "Web of Science" database
  - or at least 2 of these articles must be published (or accepted for publication) in a peer-reviewed journal referenced in the "ICONDA" database
  - or at least 1 of these articles must be published (or accepted for publication) in a peer-reviewed journal referenced in the "ASCE" database
  - or at least 2 of these articles must be published (or accepted for publication) in a peer-reviewed journal referenced in the "Scopus" database

### **Required documents**

Doctoral thesis (3 bound and 2 unbound copies, an electronic format (PDF) of the thesis)

Thesis booklet – both in English (20 copies) and Hungarian (5 copies)

The list and copies of scientific publications which relate to the thesis points (2 copies)

The minutes of the in-house defence (2 copies)

Declarations (2 copies) (*co-authors' declarations of surrender; the candidate's declaration that the thesis constitutes his/her independent work and that any verbatim citation or inclusion in content from other works has been cited appropriately; a declaration stating that the printed and electronic versions of the delivered thesis and thesis books are identical in all respects; the candidate's declaration that he/she gives his/her consent to the publication of the thesis and thesis book; the applicant's declaration that he/she is not subject to a procedure to revoke the doctoral degree, and that a doctoral degree awarded earlier has not been revoked from him/her within 5 years; A declaration that the doctoral candidate is not involved in a pending doctoral procedure launched in the same branch of science, or his/her application has not been rejected within two years, or he/she did not have any unsuccessful doctoral defence*)

New professional CV (2 copies)

Copies of the new certificates (2 copies) (*The original ones must be presented at the administration when handing in the documents*)

### **Public defence**

After the referees have written the assessments, the public discussion is organised by the administration. The HBDT evaluates the outcome of the assessment procedure based on the report of the Thesis Committee. The EHBDT shall decide on the conferral of the degree on the recommendation of the HBDT.

### **Doctoral diploma**

The official handover is organized by the EHBDT

The documents should be handed to the administration (BME K.261.) The HBDT is able to manage a case when the documents are given in minimum a fortnight before a sitting.
